Invoicing & Payment Terms

- An initial deposit of 20% is accepted by Cash, Cheque, Debit, e-transfer or Credit Card and constitutes a binding order. Due to the fact that our products are custom made, deposits are non-refundable unless prior written acknowledgement is given otherwise.
- Completed Fabrication – Prior to installation - An invoice will be created for all items that are ready for installation. Payment will be required prior to delivery or installation. Backordered items will be invoiced separately when complete.
- Installation will be invoiced once completed and terms are net 30 from invoice date.
- Outstanding balances can be paid by Cash, Cheque, Debit, etransfer or bank money transfer. Credit card transactions over \$3000.00 will be subject to a 2% fee.
- Any invoices outstanding over 30 days will be subject to a 2% monthly interest fee. In the event of the default of your obligation to pay and the overdue account is then referred to a debt collection agency, and/or law firm for collection you shall be liable for any recovery costs incurred.
